OFFICE OF THE COMMINSSIONNERS UNDER THE ACT OF APRIL 16, 1862 ENTITLED AT ACT FOR THE RELEASE OF CERTAIN PERSONS HELD TO SERVICE OR LABOR IN THE DISTRICT OF COLUMBIA

CITY HALL, *Washington City, January 13, 1863*

SIR: The commissioners would most respectfully recommend the cases embraced in the accompanying table marked C, to the equity of Congress. The claimants would be entitled in every respect to compensation, under the act, if their petitions had been filed in due time. That they were not thus field has been owing to the several causes stated in the evidence herewith presented. In some instances, the parties were in Oregon or California, and had not sufficient time, after learning the requirements of the law, to comply with them. In other cases, the parties, either living at a distance, or in Washington, confided their petitions to attorneys, who, by accident or otherwise, failed to file them. In some cases, the parties failed to petition in time, from ignorance of the provisions of the law, or of the construction that would be given to it.

The appraisalment of the slaves in all these cases has been determined on the same scale of value as the adopted in the report

WEDNESDAY, October 1, 1862

The commissioners met pursuant to adjournment. Present: Daniel R. Goodloe, Horatio King, and John M. Brodhead, commissioners; Ward H. Lamon marshal; William R. Woodward, clerk.

CHARLOTTE BECKETT AND HER FOUR CHILDREN, GEORGE, DAVID, MARY ANN, AND BOHEMIA BECKETT, SERVANT OF MARY R. BIBB.

October 1. The commissioners make and send to the clerk indorsed on the schedule the following: On rehearing of this case at the instance of the former owner, the commissioners decide, Mr. King dissenting, that it was in evidence that the woman and her children have been in the District of Columbia from the latter part of April last to the present time, and that their alleged owner has made no legal effort to reclaim them, except that a warrant was taken out for their arrest as fugitives, which has never been served nor any effort to serve it proved. The slaves are therefore entitled to their free papers under the 4th section of the amended act approved July 12, 1862; but under the circumstances of the case, the commissioners agree to recommend that compensation shall be made to Mrs. Bibb for the persons thus emancipated

CHARLOTTE BECKETT AND CHILDREN, SERVANTS OF MARY R. BIBB

Mr. Commissioner Goodloe filed the following as the reasons of the majority in the decision of the above case, October 1

Application for certificates of freedom under the act supplementary to the emancipation act approved July 12, 1862

On the 29th day of July 1862, the following petition was filed with John A. Smith, esq., clerk of

the circuit court of the District of Columbia:

"SIR: Mary R. Bibb having claim to the service or labor of Charlotte Beckett, the undersigned, and to her children, George Beckett, David Beckett, Mary Ann Beckett, and Bohemia Beckett, and having neglected to file her schedule or statement in writing as provided in the 9th sections of the act of Congress, entitled "An act for the release of certain persons held to service or labor in the District of Columbia, " approved April 16, 1862, you will please file this schedule or petition in pursuance of an act supplementary thereto, approved July 12, 1862. The petitioner files this her petition for herself and her said children, and shows that she and all her said children have resided in said District for more than three years last past, and still reside in said District by the consent of said Mrs. Bibb."

Then follows a description of the petitioners.

The attorney for the petitioner, on the same date above named, came before the commissioners with witnesses to prove the facts alleged in the petition. They testified that the woman and her children belonged to Mrs. Bibb, and resided with her in Georgetown for four or five years past, and that the servants still reside there. On the following day another witness was produced, and testified more fully to the same effect, and added that Mrs. Bibb had lately hired the servants to Captain Whipple, in Georgetown. Nothing was said by any of the witnesses going to show that Charlotte and her children had been removed beyond the limits of the District of Columbia prior to the passage of the emancipation act, or that they were not here at that time. The certificate in verification of the petition was accordingly ordered, and the clerk of the circuit court issued free papers to the petitioners in compliance with the supplementary act.
